All the rationees are requested to collect their monthly ration from their respective dealer's/sale depot w.e.f 10<sup>th</sup> to 15<sup>th</sup> of every month and if any rationee fails to collect his/her due quota of ration, the ration of previous month will not be provided to him/her in the next month.

However, the ration quota shall be distributed on monthly basis in every District, accordingly the rationees are advised to collect their ration quota on monthly basis.

The FPS dealers are directed to open their establishment from 10:00 A.M to 4:00 P.M. within all Districts including Muffasil areas and from 3:00 to 6:00 P.M in winter and 4:00 to 7:00 P.M in summer with Jammu Municipal limits daily except Sunday.
