During Physical Verification, Sales / Issuance of food grains shall remain suspended on the days of verification, if needed, and shall include all aspects including those specified in the Food Manual.

The verifying Officers shall conduct the physical verification of all food stores / Mills upto 30.04.2022. The report of Physical Verification shall reach this office by or before 30.06.2022, failing which disciplinary action shall be initiated against the defaulters.

Further, the verifying officer shall complete the assignment within stipulated time and shall submit the reports along with recommendations, spot photographs and Xerox copies of relevant data to this Directorate for further course of action.
