The deployment is subject to the conditions that the vehicle(s) whenever required /requisitioned by the Administrative Department or the Hon'ble Minister or State Motor Garages for VVIP visits or any other agencies or for the purpose of Vigilance and Enforcement activities, it shall be responsibility of the Joint Director (Admn) or the Personal Section of the Director to call temporarily for such vehicle and the Driver of such vehicles(s) shall immediately report for further duties.

Repairs /fitment of accessories /replacement of tyres and other consumables will be done with the approval of undersigned giving priority to the vehicles, keeping in view that field work, or enforcement related activity may not suffer. No approval shall be required for payment of insurance, road tax and any other taxes levied by the Government.

It is, also ordered that two number of vehicles of make Bolero/Innova will be hired on the analogy of other Government Department for utilizing them in Vigilance and Enforcement wing for making the wing mobile and as tenter works on emergent basis for effectively monitor pilferage and loss(es), if any. The arrangements are purely on need basis or till new vehicles are procured by the Department.

All the vehicles will be used for banafide official purposes only and the Drivers/Handlers or he officers using shall also ensure that Metres are properly working and log book(s) are daily updated.
