The above Authorization is however subject to the following conditions:

- I. The Assistant Directors shall furnish immediately the information sought vide this Directorate's letter No. DFCSCAJ/P&S/2107-2018/Wel.Instt/1649-64,3490-3504,3756,65,4199-4207 dated: 08-07-2017,08-09-2017,20-09-2017 & 11-10-2017 for its onward submission to the Administrative Department and Govt. of India.
- II. The cost of food grains shall be deposited in advance by Welfare Institutions with the TSO/AD concerned, who shall intimate the same with AD, T&S for

- procurement of food grains well before the expiry of validity period for depositing of cost;
- III. The Institution-wise total food grains due equal to the amount deposited by each institution shall immediately be issued to the Food Stores/Govt. Sales Depot of the concerned Tehsil Supply Officers to be issued to the Institutions in one go without any re-appropriation/diversification;
- IV. The qualification/genuineness of the Welfare Institutions in relevance to the standing orders/instructions of the government should be certified & conditions laid down vide letter No.CAPD/Plan/45/2011, dated 22/02/2012 shall also be complied;
- V. The Welfare Institutions other than government run must be registered under the provisions of the Registration of Societies Act;
- VI. The food grains at the rate of 5 Kg per head per month for indigent people living in Welfare Institutions, such as Beggar Homes, Homes for Nari Niketan etc. sponsored by the State Government shall be issued;
- VII. Hostels having students belonging to SC/ST/OBC categories are eligible to draw 15 Kgs. food grains per resident per month;
- VIII. Offtake/Issue statement and Utilization Certificate as per the prescribed format may be sent to the Directorate on monthly basis;
- IX. All other standing orders/instructions issued from time to time by the Administrative Deptt./Directorate wherever applicable must be adhered to strictly.
